Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  • Capital New York Home Advantage LLC has no affiliates.		
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • Capital New York Home Advantage LLC does not share with nonaffiliates so they can market to you.		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Capital New York Home Advantage LLC doesn't jointly market.
